The Ontario Ministry of Transportation (MTO) has retained Stantec Consulting Ltd. to undertake a Planning, Preliminary Design, and Class Environmental Assessment (Class EA) Study on Highway 401 for the replacement and rehabilitation of structures, interchange modifications, future widening of the highway, and commuter parking lot expansions, from 2 km east of Nagle Road to Percy Street (approximately 18 km). A copy of the Notice of Study Commencement and a comment form are enclosed.

The purpose of the study is to identify a Recommended Plan that addresses current and future transportation needs in the study area as part of the Ministry's ongoing review of safety and operational needs for the provincial highway network.

This study will include reviewing existing conditions, developing and evaluating alternatives, identifying appropriate improvements, and developing environmental protection and mitigation measures. A Recommended Plan will be confirmed and designated (protected) at the completion of the study.

The study includes:

- Collecting and reviewing relevant background information and seeking input from the public, Indigenous communities, and external ministries/agencies
- Carrying out field investigations to confirm environmental and engineering information
- Detailed natural science, fisheries, migratory bird, and noise studies
- A Stage 1 Archaeological Assessment

This preliminary design study is following an approved planning process under the *Class Environmental Assessment for Provincial Transportation Facilities* (2000) for a Group "B" project and will document the existing conditions and sensitivities of the study area, examine potential impacts/changes, give recommendations for proposed mitigation, and outline any commitments for future environmental work.



I would like to acknowledge receipt of your correspondence, which was received on 4/30/2018 regarding the above noted project.

As you may be aware, the area in which your project is proposed is situated within the Traditional Territory of Curve Lake First Nation. Our First Nation's Territory is incorporated within the Williams Treaties Territory and is the subject of a claim under Canada's Specific Claims Policy. We strongly suggest that you provide Karry Sandy-Mackenzie, Williams Treaty First Nation Claims Coordinator, 8 Creswick Court, Barrie, ON L4M 2S7, with a copy of your proposal as your obligation to consult to also extend to the other First Nations of the Williams Treaties.

Curve Lake First Nation is requiring a File Fee for this project in the amount of \$250.00 as outlined in the Consultation and Accommodation Standards. This Fee includes project updates as well as review of standard material and project overviews. Depending on the amount of documents to be reviewed by the Consultation Department, additional fees may apply.

If you do not have a copy of Curve Lake First Nation's Consultation and Accommodation Standards they are available at <https://www.curvelakefirstnation.ca/services-departments/lands-rights-resources/consultation/>. Hard copies are available upon request.

Based on the information that you have provided us with respect to Highway 401 Improvements. Cobourg to Colborne, GWP 4060-11-00 Curve Lake First Nation requires a Special Consultation Framework for this project, information on this Framework can be found on page 9 of the Consultation and Accommodation Standards.

In order to assist us in providing you with timely input, it would be appreciated if you could provide a summary statement indicating how the project will address the following areas that are of concern to our First Nation within our Traditional and Treaty Territory: possible

environmental impact to our drinking water; endangerment to fish and wild game; impact on Aboriginal heritage and cultural values; and to endangered species; lands; savannas etc.

After the information is reviewed it is expected that you or a representative will be in contacts to make arrangements to discuss this matter in more detail and possibly set up a date and time to meet with Curve Lake First Nation in person.

Although we have not conducted exhaustive research nor have we the resources to do so, Curve Lake First Nation Council is not currently aware of burial or archaeological sites in your proposed area. Please note, that we have particular concern for the remains of our ancestors. Should excavation unearth bones, remains or other such evidence of a native burial site or any other Archaeological findings, we must be notified without delay. In the case of a burial site, Council reminds you of your obligations under the *Cemeteries Act* to notify the nearest First Nation Government or other community of Aboriginal people which is willing to act as a representative and whose members have a close cultural affinity to the interred person. As I am sure you are aware, the regulations further state that the representative is needed before the remains and associated artifacts can be removed. Should such a find occur, we request that you contact our First Nation immediately.

Curve Lake First Nation also has available, trained Archaeological Liaisons who are able to actively participate in the archaeological assessment process as a member of a field crew, the cost of which will be borne by the proponent.

Although we may not always have representation at all stakeholders meetings, it is our wish to be kept apprised throughout all phases of this project.

Thank you for your interest in the above-mentioned project.

Please note that Karry Sandy-Mackenzie with the Williams Treaties First Nations (along with other indigenous communities) is also being consulted as part of this project.

Your comments regarding possible impacts to drinking water and the natural environment within your Traditional and Treaty Territory have been noted and forwarded to the project team for consideration. The Ganaraska and Lower Trent Conservation Authorities (CAs) have been notified of the project, and their input has been requested. Correspondence with the CAs will continue throughout the study and their input and information will aid in the development and evaluation of design alternatives. This study will identify and address vulnerable areas within the study area, whether project activities pose a threat to drinking water, whether the project (including road salt application) will create or change a vulnerable area, and discussion of how the project will adhere to applicable source protection policies.

Detailed natural science, fisheries, migratory bird, and noise studies, along with a Stage 1 Archaeological Assessment will be undertaken to aid in evaluating the improvement alternatives and selecting a Recommended Plan. This study also includes field investigations for natural heritage studies, archaeology, contamination and foundations investigations. Impact assessments will be undertaken for each study, and mitigation measures will be proposed for the Recommended Plan. Your input on existing conditions in the study area would be greatly appreciated and would help the project team during the evaluation of alternatives and impact assessments. The existing conditions, potential impacts, and proposed mitigation measures will be

documented in a *Transportation Environmental Assessment Report* (TESR), which will be available for your review and comment later in the study.

Indigenous communities with Traditional and/or Treaty Territory have been notified of the study and will continue to be consulted for the duration of the project. Thank you for your interest in the above-mentioned projects.

This letter is intended to provide you an update on the Highway 401 Planning Study and also provide a response to your comments on the Notice of Study Commencement for the Highway 401 Nagle Road Interchange Study.

Please note that Karry Sandy-Mackenzie with the Williams Treaties First Nations (along with other Indigenous Communities) is also being consulted as part of these projects.

The Ontario Ministry of Transportation (MTO) has retained Stantec Consulting Ltd. (Stantec) to undertake a Planning, Preliminary Design, and Class Environmental Assessment (Class EA) Study on Highway 401 for the replacement and rehabilitation of bridges, interchange modifications, commuter parking lot expansions, and establishing the footprint of the future six-lane and eight-lane configurations of Highway 401 to address current and future transportation needs, from 2 km east of Nagle Road to 800 m east of Percy Street (approximately 18 km).

The ministry and the Town of Cobourg have also retained Stantec to undertake a Planning, Preliminary Design, and Class Environmental Assessment (Class EA) Study on Highway 401 for a new interchange near Nagle Road in the Town of Cobourg and the Township of Hamilton (see attached key map of both study areas).

As indicated in the previous Study Commencement letters sent to you for both studies, the purpose of the two studies is to identify Recommended Plans that address current and future transportation needs in each of the study areas.

As part of the two studies, the ministry is inviting and encouraging the Curve Lake First Nation to participate in the studies to assist us in identifying the environmental, social and cultural values your community may have within the study areas. As part of the consultation program the ministry is available for a one-on-one meeting with you and other community representatives. The meeting would assist the project team in identifying and incorporating your community's values and interests in the study areas at the early stages of the preliminary design and in the development of design alternatives and evaluation criteria. Your comments regarding possible impacts to drinking water and the natural environment within your Traditional and Treaty Territory have been noted and forwarded to the project team for consideration. The Ganaraska and Lower Trent Conservation Authorities (CAs) have been notified of the project, and their input has been requested. Correspondence with the CAs will continue throughout the study and their input and information will aid in the development and evaluation of design alternatives. This study will identify and address vulnerable areas within the study area, whether project activities pose a threat to drinking water, whether the project (including road salt application) will create or change a vulnerable area, and discussion of how the project will adhere to applicable source protection policies.

These studies also includes field investigations and documentation of existing conditions for natural heritage studies (terrestrial and fisheries), Stage 1 archaeology, contamination and foundations investigations. Impact assessments will be undertaken for each study, and mitigation measures will be proposed for the Recommended Plan. Your input on existing conditions in the study area would be greatly appreciated and would help the project team during the evaluation of alternatives and impact assessments. The existing conditions, potential impacts, and proposed mitigation measures will be documented in a Transportation Environmental Assessment Report (TESR), which will be available for your review and comment later in the study.

Your comments regarding impacts to Indigenous heritage and cultural values have also been noted and forwarded to the project team for consideration. Indigenous communities with Traditional and/or Treaty Territory have been notified of the study and will continue to be consulted for the duration of the project. Any heritage or cultural concerns regarding the project will be addressed directly with the Indigenous communities and input will be encouraged throughout the project.

Your comments regarding burial sites or other archaeological sites have been noted and we will be happy to engage Curve Lake archaeological monitors for Stages 3 and 4 of the archaeological assessment process for each study, as required. As part of the two studies, we have completed Stage 1 Archaeological Assessments (AA) and the reports can be sent to you upon request. The Stage 1 AA reports have recommended Stage 2 AAs for a large portion of both study areas. As well, for the Nagle Road

Interchange Study, a Stage 3 AA is also recommended for portions of that study area. Please note that the Stage 1 AA report for the Nagle Road Interchange Study has not yet been entered into the Ontario Public Register of Archaeological Reports. The further archaeological assessments will be completed during the detail design phase of the studies once the Recommended Plan for each study has been confirmed. The ministry does not currently have a set date or a timeframe for the detail design phase for either study. You will be consulted with and notified at the start of the detail design for each study in the future.

I would further like to assure you that should the ministry and/or its retained archaeological consultant discover human remains, all legal processes prescribed by the Funeral, Burial and Cremation Services Act will be followed including the notification of the nearest First Nation Government and any other culturally affiliated First Nations.

The study team will keep you up-to-date on the status of both studies as the projects progress. We invite and encourage your input. You are also encouraged to visit the project website, www.highway401cobourgcolborne.ca to obtain current project information.

Please note that while Ontario ministries do not pay filing fees, ministries do provide support to communities when projects have the potential to adversely impact Aboriginal and Treaty Rights. The Ministry of Transportation staff would be pleased to meet with you to provide additional information about the project and answer any questions you may have. 





As you may be aware, the area in which your project is proposed is situated within the Traditional Territory of Curve Lake First Nation. Our First Nation's Territory is incorporated within the Williams Treaties Territory and was the subject of a claim under Canada's Specific Claims Policy, which has now been settled. All 7 First Nations within the Williams Treaties have had their harvesting rights legally re-affirmed and recognized through this settlement. We strongly suggest that you provide Karry Sandy-Mackenzie, Williams Treaty First Nation Claims Coordinator, 8 Creswick Court, Barrie, ON L4M 2S7, with a copy of your proposal as your obligation to consult may also extend to the other First Nations of the Williams Treaties.

Curve Lake First Nation is requiring a File Fee for this project in the amount of \$250.00 as outlined in our *Consultation and Accommodation Standards*. This Fee includes project updates as well as review of standard material and project overviews. Depending on the amount of documents to be reviewed by the Consultation Department, additional fees may apply. **Please make this payment to Curve Lake First Nation Consultation Department and please indicate the project name or number on the cheque.**

In order to assist us in providing you with timely input, it would be appreciated if you could provide a summary statement indicating how the project will address the following areas that are of concern to our First Nation within our Traditional and Treaty Territory: possible environmental impact to our drinking water; endangerment to fish and wild game; impact on Aboriginal heritage and cultural values; and to endangered species; lands; savannas etc.

After the information is reviewed it is expected that you or a representative will be in contact to make arrangements to discuss this matter in more detail and possibly set up a date and time to meet with Curve Lake First Nation in person (or virtually).

Although we have not conducted exhaustive research nor have we the resources to do so, there may be the presence of burial or archaeological sites in your proposed project area. Please note, that we have particular concern for the remains of our ancestors. Should excavation unearth bones, remains, or other such evidence of a native burial site or any other archaeological findings, we must be notified without delay. In the case of a burial site, Council reminds you of your obligations under the *Cemeteries Act* to notify the nearest First Nation Government or other community of Aboriginal people which is willing to act as a representative and whose members have a close cultural affinity to the interred person. As I am sure you are aware, the regulations further state that the representative is needed before the remains and associated artifacts can be removed. Should such a find occur, we request that you contact our First Nation immediately.

Furthermore, Curve Lake First Nation also has available, trained Cultural Heritage Liaisons who are able to actively participate in the archaeological assessment process as a member of a field crew, the cost of which will be borne by the proponent. **Curve Lake First Nation expects engagement at Stage 1 of an archaeological assessment** so that we may include Indigenous Knowledge of the land in the process. We insist that at least one of our Cultural Heritage Liaisons be involved in any Stage 2-4 assessments, including test pitting, and/or pedestrian surveys to full excavation.

Although we may not always have representation at all stakeholder meetings, as rights holders', it is our wish to be kept apprised throughout all phases of this project. Please note that this letter does not constitute consultation, but it does represent the initial engagement process.





I have reviewed these reports. There is an issue with the Stage 1 report. The use of Ontario Iroquois Tradition is implemented in this report. This is not acceptable terminology when describing time periods in Ontario. The ethnic qualifier of Iroquoian for a time period is misleading especially when describing a non- Iroquoian site.

The suggestion to be made is to call the time periods as Early Late woodland, Middle Late Woodland and Late Late Woodland.

If the Stage 1 has already been submitted, this is something that should still be passed on to Stantec for future reports, as well as to ensure this is edited for the proposed Stage 2 work/report.

As well the inclusion of the Oral history was missed in the Stage 1 report. I have once again provided the history. Please inform Stantec that it needs to be included within the MAIN body of the report for all projects conducted within our territory.
